- To provide reliable information about any medical conditions, including chronic conditions, allergies and other conditions that may affect the procedure. If you have various skin conditions, you must inform the artist in advance and have a consultation with a dermatologist, be treated if necessary and, if there are no contraindications, undergo the tattooing procedure. All information provided is confidential.
- 2. To provide reliable information concerning the presence of psychological disorders and the condition at the present moment. All information provided is confidential.
- 3. To provide reliable information regarding the presence of diseases such as: epilepsy, diabetes, cancer, blood diseases, HIV, AIDS, Hepatitis. All information provided is confidential.
- 4. To observe the rules of hygiene and wound care according to the tattoo artist's instructions received electronically, printed or verbally, and perform competent post-procedure care with the recommended preparations. Observance of hygiene contributes to the prevention of healing complications. In the event of complications during healing, the Client should immediately consult their tattoo artist. The Client shall be held personally responsible for their own health, hygiene and care.
- In case of intentional/unintentional damage of equipment and other items on the studio premises by the Client and/or their accompanying persons, the Client shall be held fully responsible for compensating financial damage to the studio and/or the tattoo artist on the fact of damage.

The Tattoo Artist shall have the right:

- 1. To refuse or stop the tattoo procedure at any stage, provided that there are factors that interfere with the work process, such as: telephone or other conversations of a harmful psychological nature, alcohol or drug intoxication, unsatisfactory hygiene of the client's body, unsatisfactory client's health condition of the physical and psychological nature (weakness, fainting, heavy bleeding etc.), deviant behavior of the client, obstruction of any nature by the client in the session such as excessive movement, simulation.
- 2. To refuse to allow the presence of unauthorized people (friends, family, partners, etc.) during the session.

- 3. If this person is an accompanying representative of a minor, in the event of harmful behavior by this person, such as psychological pressure of any nature on the tattoo artist and/or client, the tattoo artist shall have the right to refuse to allow the presence or to suspend/refuse the tattoo procedure at any stage.
- 4. To take breaks of 15 minutes every hour and a half or less depending on the circumstances and the nature of the tattooing project being carried out.

CONTRAINDICATIONS:

- Do not take drugs that affect blood clotting
- Alcohol intake less than 2 days before and 3 days after
- Acute respiratory infections, influenza and any viral diseases.

Other terms and conditions:

- The client is familiarized with the tattoo artist's portfolio and style of work
- The client is aware of the rules of booking a session, making an advance payment and the conditions in which the advance payment is withheld without refund to the client.
- The client is aware that the artist cannot guarantee the exact time required for the tattoo project for various reasons, including physiological factors.
- The client is aware that the working time of the session starts at 14:00 and lasts until 20:00 (duration up to 6 hours). The maximum free extension time is no more than 30 minutes. At the client's request and in agreement with the master, the session time can be extended on an hourly basis.
- The client is aware that the working time of the session includes the preparation of the necessary transfer of the tattoo design or the preparation of the design in the freehand technique. Depending on the project, the duration of the transfer preparation may take between 30 minutes and 1.5 hours.
- The client is aware that they have the right to book a free consultation during which the previously agreed design will be tried on. In this case, the project transfer shall be prepared in advance.
- The client is aware of and agrees to the set fee for the provision of the tattooing procedure.
- The client is aware that the tattoo studio is under video surveillance to ensure the financial, physical and psychological safety of the clients of the tattoo studio, tattoo artists and the tattoo studio. These materials shall not be given to third parties.
- The master shall not be held responsible for the sketch chosen by the client, spelling, translation, spelling correctness and meaning of the text provided and approved by the customer.
